7. Summary of Etisalat Group's performance for the last fiscal year

Etisalat Group's financial performance during the year ended 31 December 2019 is summarized in the financial metrics below:

- The consolidated revenue for Etisalat Group for fiscal year 2019 amounted to AED 52.19 billion, representing a year on year decrease of 0.38% (AED 0.2 billion). This is mainly attributable to the decrease in revenues of the international operations due to currency fluctuations and decrease in the mobile revenue of UAE operations.
- Etisalat Group consolidated profit attributable to the owners of the Company amounted to AED 8.69 billion, representing a year on year increase of 0.90% (AED 0.08 billion).
